

UPDATED CHILD HUNGER INFORMATION

On May 4, 2017, Feeding America released the full report and interactive map for Map the Meal Gap 2017.

The interactive map includes updated county and congressional district food-insecurity data, including both child and overall food-insecurity rates, federal nutrition assistance eligibility rates, average meal costs, and annual food budget shortfall estimates from 2013 to 2015.
